- \*\*The security deposit will be refunded when the rental agreement expires (less any past-due fees due or reparation for equipment/field damage).
- Long-term rental fees will be due on the first day of the month.
- Rental agreements will be approved for a maximum of 6 months; approved renters will be given first right of refusal for renewing a rental time slot.
- Contact Zonies reserves the right to change the fees at any time with a 30-day notice to all renters.

**RENTAL POLICIES FOR PROFESSIONAL INSTRUCTORS/TRAINERS:**

- A current copy of the renter's professional liability must be submitted with this request form.
- All instructors and students MUST be current members of Contact Zonies Dog Agility Club.
- Rent includes the use of the Contact Zonies field, crating area, all practice equipment, water, lights, and bathrooms.
- Class visitors are not allowed on Zonies field but can stay outside of the field fence in the gravel area.
- No one (or dogs) is allowed on the soccer field, basketball court, or in/around the swimming pool. The only exception is access to the bathrooms (humans only; no dogs allowed).
- Dogs must be on leash from the parking lot to inside the Zonies field.
- Everyone is required to pick up after their dogs and themselves. A trash receptacle is available for dog waste. Please do not leave any bulk trash on site (i.e. EZ up boxes, etc.) There are large alley trash cans to the NORTH of the parking lot (bathroom/pool side of the property).
- All instructors, students, visitors, etc. MUST sign the Melrose Swim Club's liability waiver. This waiver is part of the Zonies membership form.
- Rental time (hours) starts when the Renter enters the field and ends when the Renter leaves the field.
- Re-Scheduling: To re-schedule a date/time and avoid paying for a missed rental time, please contact the Membership Director BEFORE the scheduled rental date/time.
- Weather Cancellations: In the event that weather prevents use of the field/equipment, the renter will be allowed to re-schedule at no additional cost. The renter MUST contact the Field Coordinator on the cancelled day to request the credit.
- The outer fence gate has a combination lock. The code will be provided upon approval. If the gate is open upon arrival and/or when leaving and there are soccer or swim club people on site, leave the gate open/unlocked. The Renter is responsible for locking the outer fence gate if they are the last to leave the property.
- The poop receptacle is to be taken out and placed in the alley trash can (NORTH of the parking lot).
- If renting agility equipment, the lock combination to the storage unit will be provided upon approval.
- All equipment must be returned to storage in its original location and the lock securely closed on the storage unit.
- For night time rentals, the field lights are to be shut off when exiting. There are two light switches located on the electrical pole on the north-east corner of the field. Do NOT unplug any of the field lights. Please report any electrical/lighting problems.
- Renters have full use of the bathrooms located on the north side of the swimming pool. The combination will be provided upon approved rental.
- Alcohol and/or smoking are prohibited on the premises.

I understand that dog agility is an activity that contains inherent risks, including injury, death, and property damage to myself, my dogs or others; and represent that I am hereby voluntarily engaging in this dog agility event and any associated activities with full knowledge of the risks of injury, death, and property damage that may result from my participation in this event.

If participant is a minor (only minors between the ages of 15 and 18 may participate in Class), the minor must be accompanied to the Class by a parent or adult authorized to make decisions on behalf of the minor. The parent or accompanying adult is signing this Release and Waiver on behalf of the minor.

MELROSE PARADISE RECREATION CLUB RETURN TO FACILITY WAIVER
